ACCEPTANCE CRITERIA

- 1. User (both personas) clicks on 'Register' from the home page, opening the sign-up pop-up screen.
- 2. The sign-up pop-up screen with sub header 'Create your account' presents options such as "Looking for a facility" (seeker) and "List a facility" (owner).
- 3. If the user has an account, they can click 'Sign in' link if they 'Already have an account?'.
- 4. Clicking an option leads to an extended 'Sign up' page with the header 'Create your account,' including fields for name, email, password and country (searchable single select static drop down) and a checkbox for agreeing to the Terms and Conditions; where the all the fields are to be mandatory.
- 5. 'User with this email already exist' error message should be displayed above the user name field if user enter the pre-existing email ID to register.
- 6. Error text message (in red text) should display below the mandatory fields in the format of '<field name> is required' in the Sign-up page when user attempts to sign up without filling.
- 7. User clicks on 'Sign up' redirects to 'Additional information' page that consists of First Name, Last Name, Company Name and Phone.
- 8. If owner clicks on 'Submit' from the 'Additional information' page lands them on the 'Profile' page to add a facility center.
- 9. If seeker clicks on 'Submit' from the 'Additional information' page lands them to the home page to view all listed facility centers of either sober living or treatment facility and discover the required service.
- 10. Error text message (in red text) should display below the mandatory field in the format of '<field name> is required' in the 'Additional information' page when user attempts to 'Submit' without filling.
- 11. The registration is considered successful only if the 'Additional information' page is filled and submitted. If the user tries to close the 'Additional information' page without submission then show a warning prompt 'All changes would be unsaved if you leave' and if user click 'close' button that action get reverted else if user clicks 'submit' then the browser tab gets closed.

VALIDATIONS

- 1. Display error text messages (in red) below mandatory fields with the format '<field name> is required' on the Sign-up page when attempting to register without filling.
- 2. Display error text messages (in red) below mandatory fields in the 'Additional information' page when attempting to submit without filling





BUSINESS RULES

- 1. Owner-specific fields (Company Name, Phone) appear only for facility owners.
- 2. Agreement to Terms and Conditions is mandatory for registration.

SECURITY PARAMETERS

FUNCTIONAL LEVEL

1. Use HTTPS for secure data transmission.
